

RULES AND REGULATIONS OF THE SOCIETY

1. Admission of Members :-
 1. The persons who are subscribed to the Application for Registration.
 2. The persons at over 17 years of age who contribute annually by way of subscription of the society Rs. 5/- but subject to the approval by the Managing committee
2. Expulsion of Members :-

The Managing committee may expel the members who cause nuisance and create observations to the working of the society, with prior notice to them.
3. The General Body :-
 1. The Society shall consists of all those members who are eligible as per mentioned above.
 2. The General body meeting shall be held in every year in the month of April which is called " The Annual General Body Meeting " in which the annual Audit of the accounts of the society shall be submitted and the election of the Managing Committee and Office bearers except the president shall be held by majority of votes.
 3. The quorum for " The Annual General Body meeting shall be of more than 1/2 of the total number of members of the Society.
4. Office Bearers :-
 1. President SRI. J.M. Panchajanasara and Sri. Tegginamathada Pattadhykai or his successor from time to time shall be the Ex-Officio President of the Society.

5. Managing committee:-

1. The Managing committee shall be consist of 11 members including the president and the other four office bearers mentioned above.
2. Any casual vacancy occurring in the managing committee shall be filled by co-Operation by the remaining members of the managing committee.
3. The meeting of the managing committee may be convened by the president at least once in two months.
4. All the questions at the meeting of the managing committee shall be decided by a majority of votes and president shall have a casting vote in the event to equality of votes.
5. The quorum for the managing committee meeting will be of seven members.
6. There shall be joint responsibility of the managing committee for the working of the society.
7. Old members will continue to function until the new members are duration.

6. THE POWER & FUNCTIONS OF THE MANAGING COMMITTEE:

- i) The Managing committee shall carry on day to day administration of all the established and run by the society, through its office bearers or through sub-committee appointed by it (Managing committee)
- ii) The Rules and Regulations for the above mentioned Institutions shall be framed by the Management committee.
- iii) In the absence of the president, the vice-president shall preside over the meeting of the General Body and exercise all the powers of the
